

Consent for Processing and Storage of Sensitive Personal Information under the Data Privacy Act of 2012

Dear Valued Resident /Non-Resident, Client of Barangay Salimbalan,

The Barangay Salimbalan is committed to protecting your privacy and ensuring the security of your personal information in accordance with Republic Act No. 10173, also known as the Data Privacy Act of 2012 (DPA). This law safeguards your fundamental right to privacy while allowing the lawful processing of personal data to deliver essential services and promote community welfare.

To provide you with efficient and tailored services—such as health programs, social welfare assistance, community monitoring, and other barangay initiatives—we need to collect, process, and store certain sensitive personal information. This may include, but is not limited to, your name, address, age, marital status, health records, government-issued IDs, or other data necessary for barangay operations, as defined under the DPA.

Your Rights Under the Data Privacy Act As a data subject, you have the following rights:

- a) **Right to be Informed:** You will be notified about how your data is collected, used, and stored.
- b) **Right to Access:** You can request access to your personal information held by the barangay.
- c) **Right to Object:** You may refuse the processing of your data, subject to legal limitations.
- d) **Right to Erasure or Blocking:** You can request the deletion or restriction of your data under certain conditions.
- e) **Right to Rectification:** You can correct any inaccurate or incomplete information.
- f) **Right to Data Portability:** Where applicable, you can obtain a copy of your data in a usable format.
- g) **Right to File a Complaint:** You may raise concerns with the National Privacy Commission (NPC) if your privacy rights are violated.

Purpose of Data Processing

The Barangay Salimbalan will process and store your sensitive personal information for the following legitimate purposes:

- a) To facilitate the delivery of basic services, such as health, education, and welfare programs.
- b) To comply with legal obligations, including reporting requirements to government agencies.
- c) To maintain accurate records for the Community-Based Monitoring System (CBMS) and other local governance initiatives.

- d) To ensure public safety and security within the barangay, including emergency response planning.
- e) To support research and statistical analysis for community development, using anonymized or aggregated data where possible.

Data Protection Measures

We are committed to safeguarding your information by implementing reasonable and appropriate organizational, physical, and technical measures, including:

Secure storage systems with restricted access to authorized personnel only.

Regular audits and updates to ensure compliance with DPA standards.

Mandatory training for barangay staff and data processors on data privacy principles.

Prompt notification to you and the National Privacy Commission in case of a data breach, as required by law.

Consent for Data Processing and Storage

By providing your consent, you allow Barangay Salimbalan to collect, process, store, and, when necessary, share your sensitive personal information with authorized government agencies or partners (e.g., Philippine Statistics Authority for CBMS) for the purposes outlined above. Your consent is voluntary, and you may withdraw it at any time by notifying the Barangay Secretary or Barangay Officials in writing, subject to legal or operational constraints.
